With reference to the above cited subject, the USIEF has announced the Teaching Excellence and Achievement Program (TEA) 2011-2012 for Secondary level (Classes IX to XII) school teachers teaching English, Social Studies, Mathematics and Science at schools in the states of Goa, Gujarat, Madhya Pradesh, Maharashtra, and all Union Territories in Western India. Please note that this competition is open only to teachers from the states mentioned above and not the rest of India. In addition to teacher from India, this US Government sponsored program will bring together teachers from Europe and Eurasia, East Asia and the Pacific, the Near East, South and Central Asia, Sub Saharan Africa and the Western Hemisphere to the US for a six-week professional development program in spring or fall 2012 and will further develop expertise in their subject areas, enhance their teaching skills, and increase their knowledge about the United States.

The U.S. based customized academic program will include coursework and intensive training in teaching methodologies, lesson planning strategies as well as the use of computers for internet, word processing and as tools for teaching. Selected Indian teachers will receive round trip transportation, room and board and applicable allowances and will travel on J I Visas.

PROGRAM OVERVIEW

The International Leaders in Education Program (ILEP) will provide international teachers with unique opportunities to develop expertise in their subject areas, enhance their teaching skills, and increase their knowledge of the United States.

The International Leaders in Education Program (ILEP) is an exchange program that will provide 64 secondary school teachers from East Asia and the Pacific, South and Central Asia, the Near East, Sub-Saharan Africa and the Western Hemisphere with a semester-long professional development program at a U.S. University from January to May 2012. ILEP consists of a non-credit, non-degree academic program, including coursework and intensive training in teaching methodologies, lesson planning, teaching strategies for home environments, teacher leadership, as well as the use of computers for Internet, word processing and as tools for teaching. At the core of the academic program is a customized course in education that will connect all program components. As part of the education course, participants will work in groups to develop a unique teacher professional development module. The five month program will also include an internship at a secondary school to engage participants actively with American teachers and students. Cultural activities and academic support will be provided for participants throughout the program.

Following the international teachers' program, a group of 15 U.S. teachers from ILEP internship host schools will conduct two-week reciprocal visits in spring/summer 2013 to work with the international teachers in their home countries. International participants will have the opportunity to apply to host a U.S. teacher at their home school.

ILEP program alumni are also eligible to apply for small grants upon their return home. These grants can provide resources to conduct teacher training workshops or other activities that share the teacher's experience in the U.S. and contribute to the growth of their home education communities.

- Be current secondary school-level (9th to 12th grades), full-time teachers in a school that serves a primarily local (not expatriate) population with five or more years of classroom experience in ILEP teaching disciplines: English, Social Sciences (social studies, civics, history, economics or geography), Mathematics, or Sciences;
- Live and teach in the states of **Arunachal Pradesh, Assam, Chhattisgarh, Jharkhand, Manipur, Meghalaya, Mizoram, Nagaland, Odisha, Sikkim, Tripura, West Bengal and all Union Territories in the East;**
- Be citizens of India and qualified to hold a valid Indian passport by March 1, 2011;
- Hold a Bachelor's degree in the teaching subject with a teacher training degree;
- Be present in India at the time of submitting the application and for the interview;
- Have proficiency in written and spoken English;
- Continue teaching for at least five years after completion of the program
- Obtain a minimum score of 61 on the internet-based TOEFL (iBT) (500 paper-based) or equivalent English language examination (for short-listed candidates, USIEF will administer TOEFL or an equivalent English proficiency test) ;
- Have submitted a complete application.

Former participants of ILEP, TEA, Partners in Education (PIE), the Fulbright Teacher Exchange Program or Distinguished Fulbright Awards in Teaching Program are ineligible to apply. IIEP fellows will be selected through a merit-based open competition based on the criteria below. For this program, top candidates will be interviewed by an interview panel and must take the TOEFL (Test of English as a Foreign Language) or equivalent English language examination or provide valid results from June 2010 or later.

Selection Criteria (not in order of importance):

- Demonstrated commitment to teaching in the field of secondary education;
- Demonstrated leadership potential;
- Professional and educational experience and achievements;
- Potential for developing long-term linkages between U.S. and home country educational institutions and schools.
- Preparedness (including maturity, flexibility, and ability to function independently) for an **intensive** U.S.-based training program;
- Willingness and capacity to collaborate with international peers toward the development of a professional development module;
- Ability to express ideas clearly and effectively; and
- English language skills adequate to develop lesson plans, conduct research, audit graduate classes in U.S. host universities, and team-teach in U.S. schools (a minimum iBT TOEFL score of 61 (500 paper based) is required for IIEP program participation). For short-listed candidates, USIEF will administer TOEFL or an equivalent English proficiency test.

Applicants who have had few or no opportunities to travel to the U.S. will be given priority.
