Madam/Sir,

With reference to this Office Letter No.11083-2/2013-KVS(HQ)/Admn.I dated 16.06.2014, 17.08.2015 & 05.07.2016, wherein it has been clearly mentioned that all the subscription of membership towards recognized KVS Staff Associations (i.e. AIKVTA/KVPSS/KENVISTA) should be directly deducted from the Pay Bill of July every year (subject to the conditions mentioned in the said letter) and should be remitted to the account of the concerned Association. But till date this office is receiving many representation of treasurer of the concerned Associations that amount is not remitted by the Kendriya Vidyalayas/Regional Offices to the Bank Account of the Association.
