The Appointing Authority, however, reserves the right to terminate the services of the appointee from the post of Vice Principal before the expiry of the stipulated period of notice by making payment of a sum equivalent to the pay & allowances for the period of notice or the unexpired portion thereof.
5. He will be liable to be transferred anywhere in India.
6. He will be governed by Kendriya Vidyalaya Sangathan Employees Welfare Scheme.
7. He will be eligible for New Restructured Defined Contributory Pension Scheme only as circulated by KVS (HQ) vide Circular No. F.2-17/2003-04/KVS(Budget) dated 08/12.03.2004 and F.2-17/2003-04/KVS(Budget) dated 24.12.2004. However, in respect of the person who had joined service before 01.01.2004 in a Government Department/Organization where the CCS (Pension) Rules, 1972 are in vogue, the services of such individual will be pensionable subject to discharge of pro-rata pension liability by the parent department, where the incumbent was working earlier.
8. The appointment to the post of Vice Principal is provisional and is subject to the condition of the Scheduled Caste/Tribe Certificate/OBC/Physically Handicapped certificate being verified through proper channel. If the verification reveals that the claim of belonging to SC/ST/OBC/PH, as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provision of the Indian Penal Code for production of false certificates.

9. In case of any dispute or claim against KVS, in respect of service or any contract arising out of or following from this offer of appointment, the courts at Delhi alone shall have the jurisdiction.
10. If he accepts the offer on the terms & condition stipulated above, he shall send his acceptance latest by **17.10.2016** and shall join the Kendriya Vidyalaya mentioned overleaf on or before **28.10.2016**. If the offer is not accepted by the said date or, after acceptance, the appointee does not report for duty at his place of posting by **28.10.2016**, this offer of appointment will automatically stand cancelled and no further correspondence will be entertained in this regard.
11. Suppression of any information/providing false information will be considered a major offence for which the punishment may extend up to dismissal from the service.
