

**ORDER**

As approved by the Board of Governors of KVS in its 97<sup>th</sup> meeting held on 27-2-2014, in Schedule II of KVS (Appointment, Promotion, Seniority etc) Rules, 1971, as amended from time to time, the powers of Appellate Authority and Revisioning & Reviewing Authority in the disciplinary cases against the employees of KVS, hitherto delegated to Joint Commissioner(Admn) and as and where applicable, are delegated to the following Joint Commissioners of KVS, region-wise, with immediate effect:-

(2) Joint Commissioner(Pers)	Bhopal, Lucknow, Gurgaon, Jammu, Chennai, Patna, KVS(HQ) & ZIET Gwalior
(3) Joint Commissioner(Admn)	Mumbai, Raipur, Delhi, Hyderabad, Ernakulam, Guwahati & ZIET Mysore
(4) Joint Commissioner(Trg)	Jaipur, Ranchi, Dehradun, Bangalore, Varanasi, Silchar, ZIET Mumbai & ZIET Bhubaneswar

Accordingly, a reference to Joint Commissioner(Admn) as Appellate/Revisioning/Reviewing Authority in aforesaid Schedule II of KVS (Appointment, Promotion, Seniority etc) Rules, 1971 shall henceforth be construed to mean one of the four Joint Commissioners of KVS listed above.
