

Office Memorandum

Subject:- The cases in which family pension sanctioned under NPS to the families of deceased Central Government Employees -information -reg.

The undersigned is directed to say that consequent on introduction of New Pension System, the CCS(Pension) Rules,1972, and CCS (Extraordinary) Pension Rules were amended on 30.3.2004 to say that these rules would not be applicable to the employees appointed on or after 1.1.2004. The matter was subsequently examined and it was observed that the New Pension System was in replacement of the pension after retirement and family pension on death after retirement. Therefore, vide DoP&PW's O.M. No.38/41/06-P&PW(A) dated 5th May, 2009, it was decided that the benefits of Death-cum-Retirement Gratuity and pension/family pension may be provisionally allowed in respect of Central Government servants covered under New Pension Scheme in cases where Government servant is retired on invalidation/disability and in cases of death of Government servant in service, on rates as applicable under old pension scheme i.e. CCS (Pension) rules,1972.

2. The Department does not have the information regarding the number of cases in which the benefit of family pension, gratuity, disability pension and invalid pension has been allowed in terms of O.M, dated 5.5.2009. It is, therefore, requested that information in the enclosed proforma in respect of all the offices under the administrative control of your Ministry/Department may be sent to this Department by 30.4.2014.
