Sir/Madam,

I am to invite your attention to the subject cited above and to say that the Principals/Principal Grade-II/Vice-Principal mentioned in the list annexed would be retiring on superannuation on the dates shown against each between 30<sup>th</sup> November, 2014 to 28<sup>th</sup> February, 2015. In case any name is left the details of that Principals/Principal Grade-II/Vice-Principal may also be sent.

2. On the strength of standing instruction contained in the Sangathan's circular No.12-24/95-KVS(Admn.I) dated 15.11.96 and 19.3.97, Principals/Principal Grade-II/Vice-Principal due to retire on attaining the age of superannuation between November, 2014 to February, 2015 can be re-employed till the end of the current academic year i.e. 31.3.2015, provided they are willing for the same subject to the following conditions:-

- i) No disciplinary/vigilance case is pending or contemplated against him/her and he/she is physically and mentally alert/fit (medical certificate from CMO of Govt. Hospital) should be attached.
- ii) The Principals/Principal Grade-II/Vice-Principal is not already on extension of service after the date of superannuation.
