**MEMORANDUM**

2. The offer of promotion made under SC/ST quota is subject to production of recent certificate obtained from the competent authority of State Govt. in support of his/her continuing to belong to SC/ST as the case may be.

3. Necessary option for fixation of pay should be exercised within a month of joining to the post of HM.

4. No extension of joining time shall be allowed except for reasons of illness/confinement of the employee duly supported by medical certificate from Chief Medical Officer/Medical Supdt./Civil Surgeon of Govt. Hospital/Distt.Hospitals or from Chief Medical Officer of the Hospital of Public Sector Undertakings/Projects to which the school is attached/Military or Command Hospital as a case may be. The request, if any, for extension should be submitted through proper channel by 10.03.2015 to KVS(HQ) positively.

5. It is also made clear that representation for either change of place of posting or for extension of time to join the post (other than covered under para 4 above) will not be entertained under any circumstances.

2. The Principal, KV concerned for necessary action.
