


MINUTES OF THE MEETING OF JCM HELD ON 27-08-2015 IN DARONACHARYA KAKSH, KVS (HQ), NEW DELHI.

The Meeting of JCM was held on 27-08-2015 at 3.00 PM. in the chairpersonship of Ms. Rina Ray, Additional Secretary (SE) -Cum- Vice-Chairperson, KVS and Chairperson, JCM in Daronacharya Kaksh at KVS (Hqrs) New Delhi. The Member Secretary, JCM welcomed the Chairperson and the members of JCM from staff side and official side. Thereafter, prior to deliberation on ATR on the previous meeting of JCM and the agenda item as well, the representatives of associations requested to elect the leader of JCM.

Subsequently, Sh. S.K. Biswas, General Secretary, KEVINTSA proposed the name of Sh. M. B. Agarwal, General Secretary, AIKVTA for Leader of JCM and Sh. M. B. Agarwal General Secretary, AIKVTA proposed the name of Sh. S. K. Biswas, for Secretary, JCM. The same was accepted by all the members of JCM. Thereafter, the Member Secretary started Action Taken Report (ATR) with the permission of Chair and the following decisions were taken:-

1. ATR on Minutes of the meeting of JCM, KVS held on 28.10.2014:

1.	Sanction of post of Sub-Staff for Vidyalaya Library and Computer Laboratory	The issue was deliberated at length and the Chairperson directed to constitute a committee to examine the proposal and submit its recommendations within 03 months.
2.	Promotional avenues for TGTs (WET/ PET/ARTS/Sans) & Librarian by introducing additional subjects in + 2 Classes and TGT grade to Music Teachers:- TGTs (W.E.T, P.E.T,ART) and Librarians do not have promotional avenues and KVS should introduce additional elective subjects at plus two level in those subjects to facilitate creation of PGT posts and facilitate promotion of those teachers. Music teachers are the most neglected of the staff serving the Kendriya Vidyalayas. The essential qualification prescribed for recruitment to the post of	The Chairperson directed to send the comprehensive proposal to the Ministry of HRD within 01 month.

<p>Music Teacher corresponds to TGTs, but they are given PRT post. They train secondary and higher secondary students for all sorts of cultural functions held in the Vidyalaya, for Social Science exhibitions, Annual day celebration, to welcome and entertain VIPs visiting the Vidyalayas apart from taking regular period in Primary Classes. In NCT Delhi Schools and many other Govt. School they are given TGT grade but KVS put them in Primary Scale. It is not exaggeration of facts if we say the Music Teachers in KVS are illegally exploited, they draw the salary of PRT grade and we are compelled to work with secondary and higher secondary students.</p>


Thereafter, keeping in view a long list of ATRs and Agenda Items, the discussion on remaining ATRs and agenda items was deferred by the Chairperson, JCM, with the following directions:

- A. Pre-JCM meeting:** Sh. M.B. Agarwal, General Secretary, AIKVTA requested the Chairperson that prior to conduct of JCM meeting a Pre-JCM meeting may be conducted under the Chairmanship of Commissioner, KVS so that the minor issues can be settled there itself and the major issues only could be submitted before the JCM. The Chairperson agreed for the same and directed that a meeting of pre-JCM be conducted on 15-09-2015 at 11.00 a.m.
- B. Development of Software:** The Chairperson observed that the flow of official dak has increased manifolds. Resultantly, the important papers/ documents become untraceable or reach late to the dealing officer. The Chairperson directed that software should be developed by the KVS for fast track disposal of official dak and file movement as well. This may be developed in 2-3 months.
- C. Issue of Gate pass for General Secretaries of Associations:** Sh. P.V. Chhikara, General Secretary, KVPSS requested for issuing of Gate passes to the General Secretaries of Associations for entering in KVS (Hqrs) building. Hon'ble Chairperson directed that Gate passes may be issued to them for disposal of official work.
- D. Re-structuring of Cadres and Work Study of various establishments of KVS:** The General Secretary, KEVINTSA raised the issue of excess workload on non-teaching staff of Kendriya Vidyalayas and regional offices as well. The matter was discussed and the Chairperson was apprised by the Member Secretary, JCM that the MHRD has expressed their inability to conduct the work study of KVS as MHRD's SIU unit has been winded-up. Since KVS also do not have specialized man power in this matter, hence it was decided that re-structuring of cadres and work study may be got conducted through ISTM.
