MEMORANDUM

SUB: PROMOTION TO THE POST OF PRINCIPAL IN KENDRIYA VIDYALAYAS.

On the recommendation of the Departmental Promotion Committee for promotion from Vice-Principal to the post of Principal for the year 2012-13, the competent authority has approved the promotion of Ms. V.L. Praval, Vice Principal, Kendriya Vidyalaya No.1, Gwalior to the post of Principal in the Pay Band of Rs. 15600-39100 (PB-3) + Rs. 7600/- as grade pay and posted in Kendriya Vidyalaya, SHEOPUR. She will be treated to have been promoted notionally to the post of Principal from the date of joining of her immediate junior in the panel - Shri G.K. Jha i.e 08.01.2013 as Principal on promotion.

2. She may convey her unconditional acceptance/consent immediately to KVS (Hqrs.) quoting the above reference through the Principal of her Vidyalaya under intimation to the office of the Deputy Commissioner, Regional Office concerned also. If the offer is acceptable, he may join at the place of posting mentioned in preceding paragraph latest by 31st January, 2014 after availing the minimum joining time as admissible under rules.

3. Her pay in the above scale of pay i.e. Principal will be fixed as per provision of FR 22(I)(a)(1) as applicable to the employees of KVS. She will have an option to get her (i) pay fixed from the date of promotion OR (ii) pay fixed from the date of accrual of next increment in the scale of pay of lower grade held by her. The option shall be exercised by her within one month from the date of joining on promotion and option once exercised will be final.

4. In case, she does not want to accept promotion to the above post, she should make a written request to the appointing authority declining the same setting out reasons for such refusal. Refusal of promotion will entail no fresh offer of promotion being made to the individual concerned for a period of ONE YEAR from the date of refusal. She, on eventual promotion to the above post, will lose seniority vis-à-vis erstwhile juniors promoted to the above post earlier, irrespective of the fact whether the post in question is filled by selection or seniority.

5. This promotion is subject to the condition that no disciplinary case is pending against her and he is not under currency of any penalty.
