OFFICE ORDER

On the recommendations of the Departmental Promotion Committee and with the approval of the competent authority the following Yoga Teachers are hereby granted Selection Scale in the Pay Band of Rs.15600-39100 with Grade pay of Rs.5400 in accordance with the instructions issued by Govt.of India, Ministry of HRD, Deptt.of Education, New Delhi vide their letter No.F.5-180/86-UT-1 dated 12.08.1987, 03.11.1987 and 06.02.1989 subject to the conditions that they have possess the qualification i.e. Bachelor's Degree with three months training in yoga from recognized institution, completed 12 years of service in the Senior Scale including the old selection grade and are holding the same post on the date from which selection scale is granted. In case because of any reason whatsoever they are found ineligible for selection scale this order will be withdrawn and they will have to refund the amount drawn by them on this account.

Their pay in the selection scale will be fixed as per the provisions of FR-22(I)(a)(2) as applicable to the employees of the Kendriya Vidyalaya Sangathan. Accordingly they will have an option (i) to have his/her pay in the new scale fixed with effect from the date of grant of Selection scale or (ii) to have his/her pay in the new scale fixed w.e.f. the date of his/her next increment in the senior scale of the old post. In case, the individual opts for fixation of his/her pay w.e.f. the date of his/her next increment in the Senior Scale of the old post, his/her pay will have to be fixed at the same stage if the same stage is available or the next stage in the selection scale after allowing normal increment in the senior scale of the old post. This option should be exercised and submitted to their Principal concerned within one month from the date of issue of this order and option once exercised will be final. The details are as follows:
